



ODAC FACILITY RULES AND REGULATIONS

ARENA / BARN

- No material may be added to the arena footing.
 - A \$500.00 fine will be administered if hay and grain are placed in arena footing.
 - Non-Livestock events must leave the arena footing as it is found – level and clean from foreign objects or debris (including cigarettes – we are a NO SMOKING facility).
- Only service animals are allowed in the arena and conference center.
- No glass containers, bottles, etc. on the facility grounds.
- No helium filled balloons/items in the arena.
- No smoking or vaping in the arena area.
- Arena equipment for preparing the footing will be provided by the facility unless otherwise discussed.
- No livestock can be kept and fed in any arena. ie. main arena, warm up ring(s), etc.
- Manure is to be placed in designated receptacles only.
- No cleaning of trailers in the parking lots.
- All stalls must have at least 2 bags of shavings in them. Sawdust is prohibited.
- No overnight horses may be stabled in trailers or tied out.
- All livestock must stay behind the fenced arena area.
- Washing and bathing of animals is to be done in designated racks.
- Barn aisles and doors must remain clear and passable at all times.
- All horses must have a current, negative E.I.A (Coggins) test. All other livestock shall be free of infectious and/or contagious disease, confirmed by a Veterinarians Current Health Certificate.

FOOD VENDORS

- No cooking of any type is allowed inside the arena.
- All vendors must report to the Pittsylvania County Health Department at 1-800-434-7232 and inform of intent to serve or sell food items at ODAC.
 - A copy of proper permitting must be provided to the ODAC Facility Director one week prior to the event.
- All vendors must pay a fee to the ODAC for use of electricity/water.



PARKING

- No parking on paved lots Monday - Friday.
- Trucks and trailers – all horse/livestock transportation equipment will be parked in an organized manner in the fenced arena parking lots and overflow parking lots.
- Campers/RV's – all campers, RV's, and mobile units requiring electric and/or water hook-up will be parked in the designated areas and charged for their use.
- Events must schedule parking attendants for all events with attendance over ____ people.

SAFETY

- No smoking or vaping in the conference center, arena, barns, and farmer's market pavilion as per Virginia State Law.
- Firearms are not permitted on the premises.
- Fireworks are not permitted in the arena or on the grounds.
- ODAF management will take all precautions and reasonable steps necessary to ensure the safety of the public, exhibitors, and animals.
- Horses are absolutely not allowed to be ponied behind moving vehicles.

RV/CAMPING

- No gray water is to be dumped on the ground. Please utilize the dump station.
- Campfires are not permitted.
- Campers must leave their sites clean and dispose of refuse in the receptacles provided. All campers will be responsible for leaving the campsite as they found it. Any damage or repairs resulting from negligence shall be the responsibility of the camper.
- Any loss, theft, or accident of disturbance should be reported to the ODAC office.
- All trash to be placed in the containers provided around the facility. Those found littering may be assessed a fine.
- The use of vehicles in the RV camping area is restricted to regular roadways for entering and exiting only. Vehicles are permitted only if operated in a safe manner (this is Virginia State Law), but may not be used in the arena or in the interior of any of the barns.
- Four wheelers, ATV's, and pit bikes are not permitted on the ODAC grounds. Non-powered scooters, bicycles, skateboards, in-line skates, heelys (skate in shoes) are not permitted in the arena or the interior of any of the barns. The ODAC office reserves the right to prohibit the operation of any 'vehicle.'
- Vehicles must obey all signs. Drivers must have a valid license and insurance.



DOGS/PETS

- No dogs/pets are allowed in the conference center.
- All dogs/pets must have current vaccinations for rabies as prescribed by the state of residency. Vaccination records must be made available upon request.
- No loose dogs/pets are allowed anywhere on the premises.
 - Loose dogs/pets will incur a \$100.00 fine.
- All dogs/pets that are not crated must be on a hand-held or tied leash.
- You must clean up after your dog/pet.

ARENA CLEAN UP - POST EVENT

- All manure shall be removed from the footing and ground and deposited in the provided receptacle.
- Trash shall be picked up from the arena footing. Bleacher area, barns, and parking lot. Trash from interior trash receptacles should be deposited into the black 'First Piedmont' garbage containers.
 - One container is located on the Farm Bureau side of the arena outside the arena door. The second container is located beside the ODAC office building.
- Barns and stalls should be cleaned before leaving the premises.
- Spilled food and drink in the bleacher area shall be cleaned up as soon as possible.
- Bleacher area will be swept.
- Concrete pad will be swept after use.
- All equipment and panels used for the event will be dismantled and returned to the storage area as directed by the Facility Director.
- Failure to adhere to the cleaning rules will result in additional fees.

ODAC reserves the right to remove any camper or visitor who is in violation of these rules and regulations from the premises.

The ODAC/ODAF shall be held harmless against all claims, costs, losses or liability of every nature and kind asserted against or incurred by a camper arising or resulting in any respect from the camper's occupancy and use of the premises, and/or visitor and visitor's use of the premises.
